These successes validate that recovery is possible and we can change our future no matter what happened in our past. Three of these five graduates moved into our New Life Apartments and the other two returned to their families.

Amanda S. arrived at Rea of Hope with her own agenda for recovery in mind. "Mandy" soon realized that maybe her way of thinking was not the best and she began to work very

> hard with her sponsor on true recovery, not just abstinence from drugs and/or alcohol. Mandy opened her ears and began to listen to suggestions regarding a better way of life and began applying these suggestions. Mandy always has a beautiful smile for everyone and today her smile actually reaches her eyes.

Kimberly P. entered our program as a very quiet and emotionally damaged woman. Kim had experienced years of domestic violence and had learned to suppress all of her anger. As Kim learned more about recovery and began to work the steps with her sponsor, she began to understand her anger. Kim's passion to change and control her life has been the key to her success in recovery. She continues to take everything she learns in sobriety and applies it to her daily life. One day at a time, sometimes one minute at a time is how Kim has maintained and embraced her journey in sobriety.

Tiffany G., a young mother of two, came to us to try to remain sober and be the mother she sought to be. Tiffany had attempted sobriety several times and like many others she would stop going to meetings and working a program of sobriety. Not one to give up, Tiffany began listening to sugges-

tions, working the steps and doing the next right thing. We never had any problems with Tiffany; she would always listen to suggestions and try to change her old thought process. After graduation, Tiffany returned home to her children to work on being the Mom she wants to be. Cassie A. is a lovely young lady on the inside as well as the out-

side, Although Cassie's voice is soft-spoken, her determination for recovery is loud and clear! Never a problem and always smiling and willing to do the "next right thing", Cassie was a wonderful role

model for the other ladies. She, too, graduated and returned to

her home town.

Eden W. was delivered to us in an orange jumpsuit. Eden's addiction had landed her in jail where most of us eventually visit for short terms if not remain for many years. Eden's admission to Rea of Hope is simply "A God Thing". Rea of Hope was purchasing a new van and the exact van we wanted was in another county. Two staff members went to Nicholas County to pick the van up and the car salesman asked "what exactly is Rea of Hope?" Of course, Haley and Tammy proudly described our program. He stated that this is exactly where his sister, who was currently incarcerated, needed to come. Eden contacted us with a letter, got on our wait list, and then was admitted. Eden has been an inspiration to all. Eden attributes her success to God, Rea of Hope, and a wonderful family

that has been supportive through it all. Eden moved into our New Life Apartments to continue working on" truly living"! Thank you ladies for letting Rea of Hope be a part of your journey in recovery.







Dear Rea of Hope Supporters,

2013 has started off with a bang and busier than ever. We are excited and gearing up for our Annual Miracle on Lee Street Dinner and Silent Auction (see information below). It is hard to believe we are very close to having 100 graduates from our program since opening in May 2005. The dinner is always a hit and the speakers are what makes the night so special. Not only do we ask some of our graduates to speak but their family members too. It is very important to hear about the devastation we cause to the ones that love us the most. We have had some very courageous family members of all ages speak and the message is clear, the miracle of recovery is for the whole family. So many times families think if the addict/alcoholic in their lives stops using everything will be better and life will get back to normal. That is seldom the case; there is a lot of healing and change that needs to take place in order to grow together in recovery. Hurt feelings, trust issues and anger are the top offenders! It is unhealthy and naïve to think that all those feeling just go away because the addict stops using. Families are occasionally jealous of the time a recovering person invests in their recovery and the questions start:

- · Do you HAVE to go to another meeting?
- · Are you STILL going to those meetings?
- · You need to find another way to get to your meetings, I don't have the time or gas to take you.
- · You were never home before and you still aren't.

Yes, these are the same family members who begged, cried, pleaded and prayed for their addict/alcoholic to stop using; the answer is simple. Addiction is a lifelong disease that if left untreated can lead to death. Family members can get involved in their own recovery and see that they have been affected by this disease and that there is a support system available. The argument is often "it is not my problem; why should I have to go to those meetings" or "I don't have time, I am still cleaning up the messes made by the addict/alcoholic". When we are able to compare the disease of addiction./alcoholism to cancer, heart disease or diabetes, we would never expect to hear a loved one say:

- · Do you HAVE to do to the doctor again?
- · Are you STILL taking those treatments/medications?
- · I don't have the time or the gas to take you for your dialysis or chemo treatment.

Believe me when I say that we are fighting a deadly disease and miracles happen daily, don't be the loved one holding on to the past, jump on the recovery train and get involved, you will be a happier person for it. There is hope and a solution. Addiction/Alcoholism is a FAMILY disease, make recovery a FAMILY affair. Hope to see you all at the dinner.


Girl's Night Out

that they ever have fun again. So Rea of Hope staff takes pride in showing them how to have fun!!






to bestow upon them. I have to share that I was blessed to be a part of the most perfect moment that I have ever experienced while working at Rea of Hope. Everyone in the circle shared
