Rea of Hope, Inc. provided a safe, positive and structured home environment where mutual support and caring was a link in the recovery process. Rea of Hope, Inc. had 35 admissions during Fiscal Year 2019 with the following statistics: 82% had multiple prior treatment experiences; 75% of admissions were homeless; 89% reported domestic violence, childhood traumas and/or brutal assaults; 91% have children and only 20% of applicants were admitted. 55% of the women who started the program successfully completed Phase I (6 months) and we had 100% employment. At one year post successful discharge from Phase I, 78% are clean and sober, 84% working, 89% living in a safe place and 97% reported no new legal problems. However, if they transitioned into our Phase II program of New Life Apartments, (17 grads chose this option) one year post successful discharge; 91% are clean and sober; 97% working, 97% living in a safe place; 100% reported no new pending legal problems.
