HAD 36 ADMISSIONS DURING FISCAL YEAR 2020 WITH THE FOLLOWING STATISTICS: 79% HAD MULTIPLE PRIOR TREATMENT EXPERIENCES, 80% OF ADMISSIONS WERE HOMELESS: 81% REPORTED DOMESTIC VIOLENCE, CHILDHOOD TRAUMA AND/OR BRUTAL ASSAULTS: 77% HAVE CHILDREN AND ONLY 24% OF APPLICANTS WERE ADMITTED. 45% OF THE WOMEN WHO STARTED THE PROGRAM SUCCESSFULLY COMPLETED PHASE I (6 MONTHS) AND HAD 100% EMPLOYMENT.
